1. Introduction

The Shoe 5.0 project aims to prepare the EU footwear sector to embrace the transition challenge to a sustainable, human-centric, and resilient industry, transcending efficiency and productivity objectives and allying benefits for industry, workers, and society.

The project implementation started with the analysis of the current integration of the industry 5.0 principles in the Footwear sector, the study of the current and future footwear workforce and the match with the footwear professional profiles, meaning footwear jobs, the development of updated profiles and training itineraries and the correspondent contents. The next stage is to pilot the developed learning solutions in the 4 countries involved, namely Portugal, Spain, Italy, and Romania, which will be mainstreamed in the near future.

Piloting the educational framework created on a scale and evaluating the learning experience's results is fundamental to fine-tuning the Shoe 5.0 training kits (for trainers and trainees) and the self-assessment tools.

Several Awareness Sessions, planned in each partner country, anticipate the piloting. These sessions aim to inform stakeholders about the project's progress, disseminate key findings, generate interest, gather feedback, and encourage active participation in future pilot sessions.

This report describes the main points of the Awareness Sessions held by the different partners: TUIASI, POLICAZ, CEC, CTCR and CTCP.

A total of 7 Awareness Sessions were held:

- **TUIASI** hosted their Awareness Sessions on the **14th and 16th of October 2024**;
- **Politecnico Calzaturiero** held their Awareness Sessions on the **17th and 30th of October 2024**;
- **CEC** organized an online Awareness Session on the **15th of October 2024**;
- **CTCR** hosted their Awareness Session on the **23rd of October 2024**;
- **CTCP** held their Awareness Session in Porto on the **17th of October 2024**.

2. Recruitment and Advertising

The Shoe 5.0 Awareness Sessions were addressed to employees of small and medium enterprises, representatives from the footwear sector association, teachers, students, and freelancers.

The participants were invited to participate through personalised emails, social media and via direct phone call.

3. Awareness Sessions

3.1 TUIASI Awareness Sessions

TUASI held two Awareness Sessions: an online session, organised through the Google Meets platform on October 14th, 2024 that gathered 12 participants and an onsite session, held on October 16th, 2024, in Iasi, Romania, at the Faculty of Industrial Design and Business Management (DIMA) that gathered 8 participants.

Both activities were attended by **20** participants:

- **10** employees of Romanian footwear companies
- **2** teachers
- **7** students and freelancers
- **1** Representative of Footwear Sector Associations (Footwear Engineer)


The session was attended by **18** participants:


- 6 employees of European Footwear enterprises


3.5 CTCP Awareness Session

- 6 students, teachers or freelancers.


